THE HEAD START PROGRAM OFFERS COMPREHENSIVE EARLY CHILDHOOD SERVICES TO CHILDREN AGES BIRTH-5 AND FAMILIES WITH LIMITED INCOME AND FOR CHILDREN WITH SPECIAL NEEDS THAT RESIDE WITHIN CLAY AND WILKIN COUNTIES. LAST YEAR THE LAKES & PRAIRIES HEAD START PROGRAM EXPANDED SERVICES TO INCLUDE 2 DURATION CLASSROOMS THAT PROVIDE FULL-DAY, FULL YEAR PROGRAMMING. THESE CLASSROOMS OPERATE AT OUR NEW SATELLITE LOCATION IN SOUTH MOORHEAD. THE HEAD START PROGRAM PROVIDES HIGH-QUALITY EARLY CHILDHOOD EXPERIENCES TO OVER 300 CHILDREN EVERY YEAR. OVER 90% OF ENROLLED CHILDREN MEET ALL DEVELOPMENTAL BENCHMARKS IN THE PROGRAM YEAR.
